

# Health Center Week August 2024 Phone Scripts

## We ask that all ACH members participating in Health Center Week 2024 coordinate calls on the following days:

- On Monday, August 5, we ask all Health Centers to jointly use the 340B Drug Pricing script.
- On Tuesday, August 6, we ask all Health Centers to jointly use the Funding script.
- From Wednesday, August 7, through Friday, August 9, we encourage Health Centers to reuse the 340B or Funding scripts, or to customize any of the remaining scripts that strongly resonate with your centers' priorities:
  - Emergency Preparedness
  - Health Equity
  - Innovation
  - Value-Based Care
  - Workforce

### **Helpful Tips & Tricks:**

- To contact your Senator or Representative's office, you can call the U.S. Capitol Switchboard at 202-224-3121 and ask for your Senator or Representative's office, or <u>find Representatives' direct office lines here</u> and <u>Senators' direct office</u> lines here.
- When sharing this template at your center, replace any italicized text possible with your information; only leave the portions that need to change for individuals (i.e., name)
- Include any relevant information about your specific health center, patient population, or needs; just keep in mind that the recommended length is 30 seconds to 2 minutes.
- Your call should convey urgency in its call to action.
- Repeating your center's name, as well as the name of Advocates for Community Health, increases the likelihood of follow-up.
- Invite your member to visit your health center when they are back in the district to further your call's impact.



## 340B Drug Pricing - Monday, August 5, 2024

# Funding (CHC Reauthorization Fund) - Tuesday, August 6, 2024
