# The Latest From DC

### What We Know About the Federal Funding Freeze

On Tuesday, the White House OMB issued a memo <u>rescinding its memo on Monday</u> <u>that ordered all agencies to freeze federal grant funding</u>. Soon after, White House Press Secretary Karoline Leavitt <u>released a statement</u> saying it was: "NOT a recission of the federal funding freeze. It is simply a recission of the OMB memo...The Executive Orders issued by the President on funding reviews remain in full force and effect and will be rigorously implemented by all agencies and departments. This action should effectively end the court case and allow the government to focus on enforcing the President's orders on controlling federal spending. In the coming weeks and months, more executive action will continue to end the egregious waste of federal funding."

This means that while the initial freeze has been lifted, future restrictions could still be implemented. Unfortunately, there is continued confusion around the scope and implementation of this policy.

ACH is staying in close contact with congressional contacts and other relevant stakeholders to advocate aggressively for swift resolution for health centers to ensure access to grant funding is not paused or disrupted.

For now, we are reasonably confident that health centers should have normal access to federal funds. Please <u>reach out to us</u> if you cannot access grant funds through PMS or other government sources. We are also confident that the Administration will continue to evaluate federal grant programs for compliance with President Trump's executive orders on DEI, gender-affirming care, and other issues. We will keep you posted as we learn more about how these actions may impact community health centers and their patients.

Given the unpredictability of federal funding, ACH urges you to inform your members of Congress about the importance of protecting health centers and their patients.

# **Call to Action:** Tell Congress to Lift the Freeze in Federal Funding for Health Centers

As the new President and Administration implement a strategy to administer government programs as they see fit, these oversight efforts must be done precisely to ensure patients have access to care. Unfortunately, even with the best intent, this type of funding freeze can do tremendous harm.

This week, a federal judge in the District of Columbia temporarily blocked the order in response to a lawsuit filed that argued that the directive violated the First Amendment and a law governing how executive orders are to be rolled out.

The judge said she would issue a more permanent decision on Feb. 3.

# **ACH Policy Priorities in Action**

ACH Featured in CBS News: White House Blames "Outage" for Locking Out Medicaid, Head Start, Health Centers from Funding Site "Even with the best intentions, these funding freezes can do tremendous harm. And could be irreversible to some communities," said **ACH CEO Amanda Pears Kelly.** "What we're really talking about is a health center's ability to pay salaries."

**Pears Kelly said** that health centers often rely on being able to request money every other week through the system, drawing down their grant to pay bills and make payroll for their staff. Without the money, she warned many health centers facing already slim margins could be forced to trim staff or close their doors.

"When the system's down, and there's no one to talk to to understand what they need to do, and then on top of that there's an uncertain time to the delay, it's paralyzing," **said Pears Kelly.**

## ACH Members Receive HRSA Grants to Expand Hours at Community Health Centers

Best Practices Spotlight: Jordan Valley Community Health Center

<u>Jordan Valley Community Health Center (JVCHC)</u>, Missouri's largest FQHC, has begun taking walk-in appointments at all nine locations across southwest Missouri thanks in part to a \$1 million investment over two years to improve access to health care services. Walk-in appointments will provide services like dental, primary care, vision, and substance use disorder treatment. They allow a patient to visit any Southwest Missouri JVCHC clinic without a scheduled appointment.

"By offering a variety of walk-in services across all locations, we are continuing to make visiting a health provider more convenient while responding to the needs of our community," said Melissa Wehner, vice president of operations. "We are committed to providing high-quality, accessible care to all."

Walk-in services include behavioral health and medicine, dental, express care, foster care support and resources, pediatrics, women's health, and vision.
