Dear Majority Leader Thune, Minority Leader Schumer, Speaker Johnson, and Minority Leader Jeffries:

We, the over 800 undersigned executives leading many of the nation's community health centers, state and regional primary care associations, and related organizations, thank you for your strong bipartisan support of the Community Health Center Fund, most recently demonstrated in the Full-Year Continuing Appropriations and Extensions Act, 2025 (CR). Under your leadership, lawmakers continue to recognize the importance of providing community health centers with the federal resources they need to serve some of the most at-risk, medically fragile communities in our nation. Moreover, lawmakers also demonstrated their commitment to key workforce programs in the CR like the Teaching Health Center Graduate Medical Education (THCGME) program and the National Health Service Corps (NHSC). We are greatly encouraged by this support and are grateful.

As Congress continues its work to reform our nation's health care system and fund federal government operations, we urge you to do even more to support the important work community health centers do by protecting and stabilizing a federal program that community health centers rely on most - the Medicaid program.

Medicaid improves health outcomes, reduces premature deaths, and strengthens the economy, while funding efficient, cost-saving care at community health centers that many rural and low-income Americans rely on. We support a targeted approach to changes in Medicaid policy, as broad

changes have the potential to destabilize state Medicaid programs and community health centers, harm local economies, and exacerbate rural health care access challenges. We are committed to working together to refine any proposed changes, ensuring Medicaid remains a strong, reliable resource for the patients and communities who depend on it most.

We understand Congress is exploring ways to reduce administrative and inefficient spending, including within Medicaid, and we are ready and committed to working with you on this important effort. However, health centers stand to be doubly impacted by substantial reductions in Medicaid coverage and funding, given that we are required by law to serve all patients no matter their ability to pay. We are proud to be our country's largest network of primary and preventive care, providing access to high quality care to more than 32 million patients, but changes that both reduce coverage levels and squeeze state budgets would impose serious burdens on health centers. These types of changes would lead to job losses and far-reaching economic impact. We respectfully urge you to collaborate with community health centers to ensure any changes to the Medicaid program protect rural and struggling areas and their trusted providers.

We appreciate your consideration of our issues and stand ready to work with you to help ensure an even more effective and efficient health care system.
